## Establishment of an Overseas Subsidiary and Acquisition of Shares in BPO Bangkok Co., Ltd.

SocioFuture Co., Ltd. (Minato-ku, Tokyo; Akihiko Sugawara, Representative Director, President & Executive Officer and COO; hereinafter referred to as “the Company”) has established an overseas subsidiary, SOCIOFUTURE (SINGAPORE) PTE. LTD. (Takayuki Niitsu, Representative; hereinafter referred to as “SOCIOFUTURE (SINGAPORE)”), in Singapore as part of its business expansion in the ASEAN region. The Company will form a corporate group in the ASEAN region with SOCIOFUTURE (SINGAPORE) as its holding company and will develop social infrastructure-related businesses by leveraging the expertise and technological capabilities cultivated in Japan.

As part of this initiative, SOCIOFUTURE (SINGAPORE) has acquired all issued shares\* of BPO Bangkok Co., Ltd. (Ryuichi Itaya, Representative; hereinafter referred to as “BPO Bangkok”) with the aim of advancing its business operations in Bangkok, Thailand. Ryuichi Itaya, Representative of BPO Bangkok, will subscribe to a planned capital increase of SOCIOFUTURE (SINGAPORE) and will participate in the Company’s business expansion in the ASEAN region as well as in the growth of BPO Bangkok.

BPO Bangkok was established in Bangkok in 2010 with certification from the Thailand Board of Investment (BOI) and provides business process outsourcing, call center services, and data management services to companies in Japan. Going forward, the Company will continue to provide the same services, while also promoting BCP services for the Japanese market and developing and expanding new services for the Thai market.
