Acquisition of Shares of I-AGREX (THAILAND) CO., LTD.

SocioFuture Co., Ltd. (Minato-ku, Tokyo; Akihiko Sugawara, Representative Director, President & Executive Officer and COO) and SOCIOFUTURE (SINGAPORE) PTE. LTD. (Takayuki Niitsu, Representative) have acquired all issued shares of I-AGREX (Thailand) Co., Ltd. (Hideo Teramoto, Representative; hereinafter referred to as "I-AGREX"), which were held by AGREX Inc. (Shuji Yamamoto, Representative) and two other companies, as part of their business expansion in the ASEAN region.

I-AGREX was established in Bangkok in 2012 with certification from the Thailand Board of Investment (BOI) and provides business process outsourcing and call center services to Japanese companies operating in Thailand and companies in Japan. Going forward, together with BPO Bangkok Co., Ltd. and ATMJ Thailand Co., Ltd., which are already providing BPO services in Thailand, the Company will expand its BPO services for the Japanese market and for Japanese companies operating in Thailand.
